Payment not made by the due date shall be considered an overdue account and shall bear interest "at the Rate Notified" compounding monthly from the due date until the date of actual payment.

Product Installation When installing products Compucar will ensure that; The invoice will define, the cost, work involved, parts that need replacing

The product is working properly once installed and tested That Compucar is satisfied with all aspects of installation/maintenance work.

### Servicing

RETURNS All items returned are subject to a 10% (ten percent) restocking fee. Returns are not accepted on ignition systems, computers, electrical units, software, special orders and custom orders. All returns or exchanges are accepted within 14 days after date of invoice. It is the customer responsibility to contact COMPUCAR DIAGNOSTICS LTD within this time period to be eligible for a return.
